# Bankruptcy

# Cadastral Registration



- Cadastral registration is a system for documenting properties in a dedicated land registry, which certifies ownership and displays all data related to the property, including area, boundaries, location, rights, and restrictions.
- This system is one of the modern real estate systems in Saudi Arabia, providing stronger protection for ownership, reducing disputes, and enhancing confidence in the real estate market.
- Cadastral registration is governed by the Cadastral Property Registration System issued by Royal Decree No. (M/٦) in ١٤٢٣هـ, and is overseen by the General Authority for Real Estate and the Ministry of Justice.





# Notarization



- The notarization service is a legal procedure aimed at validating the authenticity of legal actions, such as contracts, power of attorney, acknowledgments, mortgages, and agreements, through a certified notary or official authority.
- The Saudi Ministry of Justice has enabled licensed lawyers and certified notaries to provide this service via the "Tawtheeq" or "Nafez" platforms, offering flexibility and speed in completing transactions.

# Large Estates
